Pandemic Recovery Program

In response to the COVID-19 pandemic, Calgary Foundation has established a new Fund to address the needs of the charitable sector. Like the Flood Rebuilding Fund of 2013, Calgary Foundation will work alongside other community leaders to assist the good work of Calgary and area's charitable sector to support individuals and communities.

The Pandemic Recovery Program will have three phases of support, rolled out over time:

Phase 1: **Relief** phase will support the immediate needs of charities to connect with staff, board, and other stakeholders. This funding provides short-term space and time to plan for recovery.

Phase 2: **Recovery** phase will focus on activating strategies to get charitable operations back to pre-pandemic levels.

Phase 3: **Resilience** phase will support strategies and technologies for strengthening organizations for the operational future.

Calgary Foundation has partnered with United Way of Calgary and Area, Calgary Emergency Management Agency, and the City of Calgary to address social service needs through this Fund. ****

Pandemic Recovery Program Grants

Grants support qualified doneesⁱ across the charitable sector in their Relief, Recovery, and Resilience efforts... Calgary Foundation will be responsive to the needs of Calgary, the surrounding area and Treaty 7 First Nation communities, by making grants outside the parameters of these guidelines when appropriate.

Examples of initiatives the Program will support include, but are not limited to:

- Organizational Planning - recovery strategies, exploring new operating models or mergers.
- Technology and Communication - working remotely, maintaining social distancing, informing stakeholders.

- Support for Equity-Seeking and Vulnerable Populations - reducing isolation, translation services communication.
- Short-term unrestricted support to ensure organizational continuity.
- New programs that respond to pandemic-related needs.

What activities are ineligible?

The Pandemic Recovery Program is not intended to address economic relief for individuals, social service programs supported by other funding programs, or other economic relief efforts supported by provincial and federal governments, or financial institutions.

Who can apply?

Qualified donees that serve individuals, communities or neighbourhoods affected by the COVID-19 pandemic within one or more of the following regions can apply:

How grants are selected

Applications will be reviewed by a volunteer committee consisting of community leaders, volunteers, and sector experts. Applicants will be notified approximately two weeks after submitting their applications.
